



**Puyallup Tribe of Indians  
Gang Task Force  
Graffiti Abatement Program  
Removal Permission Form**

THE UNDERSIGNED, owner of the improved real property located at: \_\_\_\_\_, on the Puyallup Indian Reservation does hereby authorize the Gang Task Force and/or Representative(s) to remove the graffiti located at the above address from the \_\_\_\_\_ day of \_\_\_\_\_ to one year later, subject to the following terms and conditions:

1. The undersigned acknowledges that he has not caused, allowed or permitted the placement of the aforementioned graffiti, and that the undersigned will cooperate with the Puyallup Tribe of Indians Gang Task Force in ascertaining the identity of the person or persons responsible for said graffiti, and prosecuting the said person or persons.
2. The Puyallup Tribe of Indians Gang Task Force, through its authorized employees or contractual agents, is hereby authorized to enter the aforementioned property of the undersigned to remove graffiti from said premises. I understand that the process for removing graffiti is by painting over with donated paint, trying to match the existing surface color to the degree possible. I understand that the painting may be done in blocks or stripes only where the lettering appears and that the affected area may not match existing color precisely; nonetheless, the Puyallup Tribe of Indians Gang Task Force assumes no responsibility if colors do not precisely match.
3. It is also understood that this authorization is given for the removal of the current incident of graffiti and all future incidents of graffiti, which occur within the next one (1) year so long as the undersigned is owner of the subject property. Only verbal verification of continued ownership will be obtained during this one (1) year period prior to removal of any subsequent graffiti incidents.
4. It is understood that the undersigned shall not be charged for said services and that in consideration of the aforementioned services, the Puyallup Tribe of Indians Gang Task Force shall not be liable to the undersigned for any damage to person or property occasioned in the removal of said graffiti, including damage to the person or property of the undersigned. The undersigned acknowledges that the Puyallup Tribe of Indians Gang Task Force does not guarantee either the workmanship or the success of the work of removal of said graffiti or the results obtained and that Puyallup Tribe of Indians Gang Task Force, its agents and undersigned, or his or her heirs or successors in interest may have by reason of the failure of Puyallup Tribe of Indians Gang Task Force to perform said work of removal in a satisfactory or workmanlike manner or by reason of the failure of Puyallup Tribe of Indians Gang Task Force to exercise ordinary care resulting in damage to person or property of the undersigned.
